

## NOTICE FOR WRITTEN EXAMINATION AND INTERVIEW

MP. Power Transmission Co. Ltd. has published advertisement to fill up various vacant positions of E.T.(Accounts) Trainee and Dy. Director (Finance & Accounts) vide advertisement No.AS/MPPTCL/245 dated 14.11.2011. In sequel to above advertisement, written examination shall be conducted on 29th January, 2012 at Human Resource Development Institute, MPPTCL, Nayagaon, Jabalpur from 8.00 AM. Thereafter interview of eligible candidates shall also be held on the same day from 11.30 AM (29.01.2012) and 10.30 AM onwards on 30.01.2012. Therefore, candidates may present themselves for attending selection process on scheduled date and time accordingly. All provisionally eligible candidates have been informed individually through speed post. Non receipt of admit card, candidate may download the list where his/her name is appearing, required to be present the same before appearing for the written examination/interview at the scheduled place / date and time along with all the necessary documents as indicated hereunder:-

1. Proof of Date of Birth (Matriculation/HSSC Certificate)
2. One recent Passport size photograph duly attested by a Gazetted Officer.
3. All original Certificates, Degree and Marks Statements of various examinations/courses in support of qualifications as mentioned in your application form as per the eligibility criteria.
4. Caste Certificate, in case of candidates belonging to SC/ST/OBC (Non Creamy layer) categories as specified in respect of State of MP (in the prescribed format of Govt. of M.P.) SC/ST candidate belonging to other states are not entitled for reservation facility as specified in the advertisement.
5. In case of eligible SC/ST candidate, proof of journey ticket and its one photocopy is required for reimbursement of fare by the shortest IInd class Train fare/Bus fare from his/her address of M.P.. In case, He/She presently resides outside M.P. State for reasons whatsoever he/she will be paid fare of bus/IInd class train fare restricted to the shortest route upto the nearest point of M.P.State Border i.e. out side M.P.State Border no fare shall be admissible.
6. Please ensure to bring this call letter (in original) at the time of attending the written examination/interview.
7. Candidates working in Central/ State Govt. are required to bring NOC from their employer at the time of Interview. Permanent departmental candidates of MPPTCL/MPSEB will have to produce certificate regarding his present posting against regular cadre from the Controlling Officer, otherwise their candidature as a permanent departmental candidate shall not be considered.
